- **Philanthropy & Kingdom Giving:** Allocating funds to ministries, charities, and mission-driven organizations.





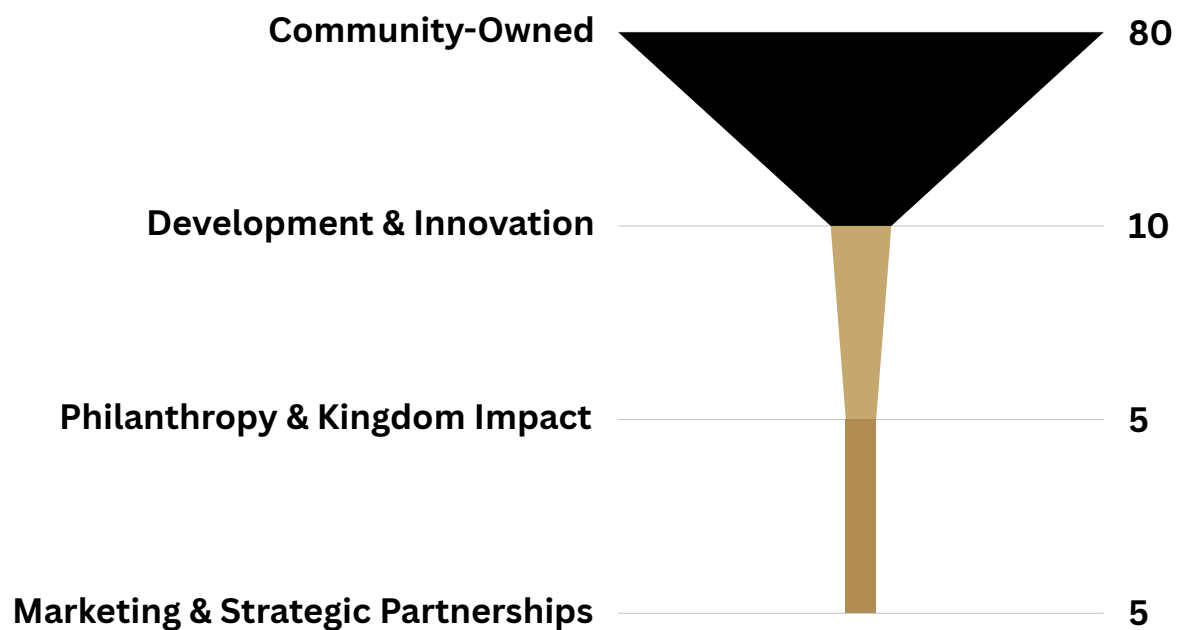
Tokenomics

Vesting Schedule & Token Release Plan

The \$CWOI (Common Wealth of Israel) Token is designed with a structured vesting schedule to ensure sustainability, market stability, and long-term value for investors, community members, and ecosystem participants. This approach prevents excessive token supply flooding the market while incentivizing long-term commitment and decentralized governance.

Vesting Allocation Breakdown

To maintain transparency and stability, the \$CWOI token distribution follows a three-phase vesting schedule over a three-year period, along with a dedicated allocation for staking, rewards, and community incentives.

1. Initial DEX Offering (IDO) & Relaunch – 1/3 Allocation (33.3%)

- Objective: Provide immediate liquidity and market entry to establish initial value.
- Release Schedule:
 - 33.3% of total supply will be released during the IDO and relaunch phase.
 - Tokens will be available for purchase on decentralized exchanges to kickstart trading.
 - Investors can participate in early-stage access, ensuring a balanced and fair launch.
 - Ensures that early supporters and liquidity providers benefit from immediate availability.

2. Main Launch Phase – 1/3 Allocation (33.3%)

- Objective: Support broader adoption, strategic partnerships, and increased token circulation.
- Release Schedule:
 - Another 33.3% of total supply will be unlocked during the official launch of \$CWOI.
 - This ensures price stabilization and prevents a sharp post-launch dump.
 - Strategic allocation to developers, investors, and institutional buyers to ensure ecosystem growth.





1. Prelaunch & Initial DEX Offering (IDO) - 1/3 Allocation (33.3%)

Timeframe: Estimated 3 to 6 months (depending on traction & marketing effect)

What is IDO?

An Initial DEX Offering (IDO) is a decentralized crowdfunding method that allows early investors to acquire \$CWOI tokens through a decentralized exchange (DEX). Unlike traditional fundraising models, an IDO provides liquidity, transparency, and accessibility to the broader crypto community.

Token Release Details:

- 33.3% of the total token supply will be allocated for the IDO and prelaunch phase.
- This phase is crucial for price discovery, liquidity establishment, and initial adoption.
- The duration of 3 to 6 months depends on how quickly the token gains traction through marketing, partnerships, and community engagement.
- Tokens will be sold at an initial price point, providing early adopters with the opportunity to participate before the full-scale launch.

2. Main Launch Phase - 1/3 Allocation (33.3%)

Timeframe: Estimated 6 to 12 months (Post-IDO Phase)

Token Release Details:

- 33.3% of total supply will be unlocked during the main launch phase, which follows a successful IDO.
- This phase introduces broader exchange listings, increased liquidity, and adoption growth.
- Distribution occurs in staged releases over 6 to 12 months to maintain price stability and avoid extreme market fluctuations.
- This phase attracts institutional investors, strategic partners, and ecosystem developers, further embedding \$CWOI into the digital economy.





3. Governance-Controlled Vesting & Ecosystem Growth - 1/3 Allocation (33.3%)

Timeframe: Estimated 1 to 3 years (Gradual Release Over Time)

Token Release Details:

- The remaining 33.3% of the total supply will be locked and vested over a 1 to 3-year period.
- Distribution will be governed by the \$CWOI Governing Board, ensuring a strategic, data-driven token release that aligns with market conditions and ecosystem expansion.
- This approach protects against oversupply and prevents premature price drops, allowing \$CWOI to retain strong valuation.
